Bar: Separate room at end of the hall for serving with cooler.

KITCHEN:: Fully equipped commercial kitchen.large walk in cooler, serving warmers, dishwasher, ect

MEETING ROOM: Can be used for food serving area

FLOOR: Wooden dance floor 32' \times 56'. Surrounding floor is tile 12' on each side and 8' at the back of the Hall **BOARDS FOR DECORATING**: Set of five on each side and two up front. Large 8' \times 5 ½". Walls are not to be used

for decorations.

ELECTRICAL: 220 volts available at stage for a band

CANCELLATION: The Hall reserves the right to cancel this rental agreement prior to a function at any time, subject to full refund of the deposit. Cancellation by the renter shall require a minimum of three months' notice for a 50% refund of the deposit. No refund will be given for any cancellation with only two (2) weeks' notice prior to the function. All refunds will be at the discretion of the Board.
