That the following Stop sign be added at

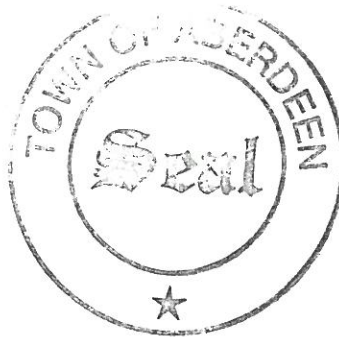


