## BUSINESS LICENSE - Bylaw No. 12-14

The Town Council of Aberdeen has adopted a new Business Bylaw 12-14 that requires all businesses whether store front, home based, any trades or professions to obtain a Business License.

**All businesses must register with the Town of Aberdeen annually. The deadline to register has been extended to February 29<sup>th</sup>, 2016. Conducting a business without a license can result in fines of \$200.00.**

## 2016 DOG / CAT REGISTRATIONS

All dog and cat registrations are due annually. If you are a pet owner living in Aberdeen and do not have your animal(s) registered, please stop by the Town Office and have your pet(s) registered **TODAY!**

**Spayed or Neutered: \$25.00 OR \$50.00 if NOT Spayed or Neutered**

There are no registration fees for cats, but failure to register could result in a fine. **Bylaw 13-2015 states that failure to register your animals can result in fines of \$100.00 per animal.**

**MONTHLY TAX DISCOUNTS / PENALTIES:**

Taxes are imposed the first day of January in each year and are due July 31.  
**Please remember there is NO discount for the School Portion of Taxes**

**For prompt payment of 2016 taxes the following discounts are allowed:**

Payments received in January 6.5% discount  
 Payments received in February 5.5% discount  
**Payments received in March 4% discount**  
 Payments received in April 3% discount  
 Payments received in May 2% discount  
 Payments received in June 1% discount  
 Payments received in July .5% discount



**Penalties for 2016 Tax arrears will be as follows:**

August 1 (compounded monthly)	1%
September 1	1%
October 1	1%
November 1	1%
December 1	1%

**On January 1, 2016 an additional 12% penalty was applied to 2015 arrears**
